

AXIS AGGRESSIVE HYBRID FUND

An open ended hybrid scheme investing predominantly in equity and equity related instruments

(Formerly known as Axis Equity Hybrid Fund)

About the Fund

Axis Aggressive Hybrid Fund is an open ended hybrid scheme investing in equity as well as debt instruments. The fund has a balanced approach to investment with an asset allocation to both asset classes. The fund is categorized as an aggressive hybrid fund as it invests majority of the portfolio in equity and the balance in debt

Why Invest?

- Multi-asset strategy helps in portfolio diversification
- Combining asset classes with low or negative correlation reduces investment risk and captures potential upside
- Gives a balance of mix asset classes while maintaining equity taxation attributes
- Emphasis on quality portfolio

Investment Approach

- › **Equity** – The fund typically invests 50-70% of its portfolio in large cap companies with stable growth metrics and consistently high ROE/ROCE numbers. The mid and small cap companies generally comprise of 10-30% of the portfolio. These are companies which have high growth and disruptive business models.
- › The fund invests 0-10% of the its portfolio in event specific ideas and the balance in frontier ideas. These are companies with favorable cyclical tailwinds and beta plays.
- › **Debt** – The fixed income portion of the fund has a target portfolio duration of 1-7 years. The fund is actively managed and has a diversified portfolio. It is a mix of high quality corporate bonds and G-secs.
- › It aims to capture opportunities in the yield curve spreads in the short to medium duration segment.

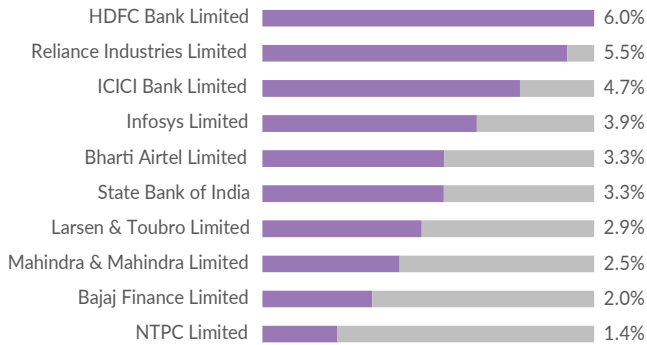

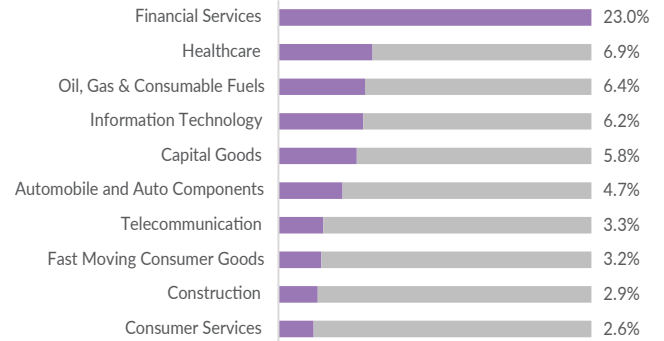

Top 10 Stocks##



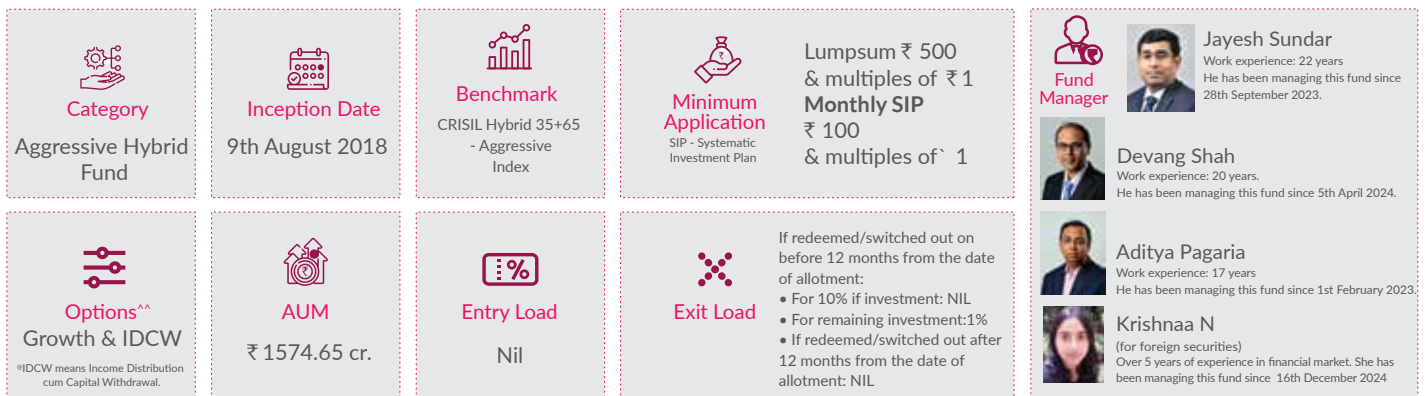
Top 10 Sectors##

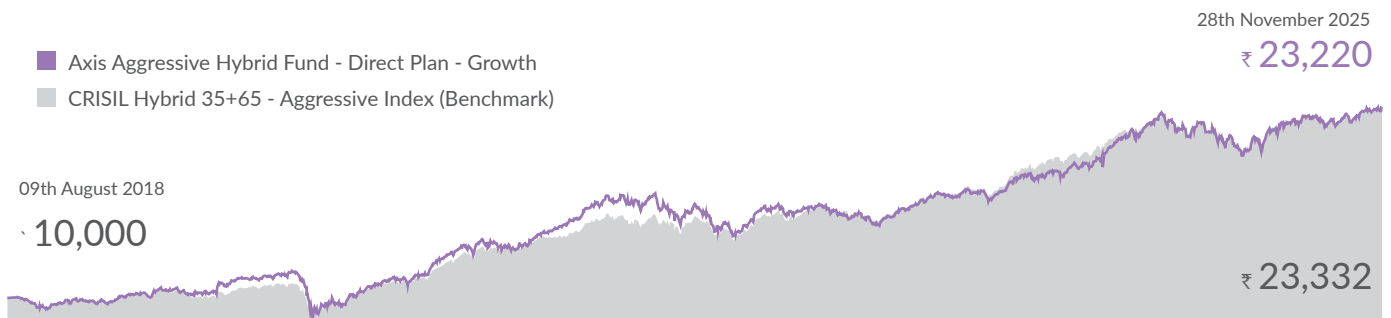
