

AXIS CONSERVATIVE HYBRID FUND

An open ended hybrid scheme investing predominantly in debt instruments
(Formerly known as Axis Regular Saver Fund)

About the Fund

Axis Conservative Hybrid Fund is categorized as a conservative hybrid fund which allocates in a combination of debt and equity. It is ideally suited for investors who want to generate a steady income through debt investments and wants to add some alpha to their portfolio via equity.

Why invest in Axis Conservative Hybrid Fund?

- Potential for higher return than debt. Lower risk than pure equity oriented scheme.
- The fund is ideally suited for conservative investors who are looking for slightly higher returns than traditional fixed income funds.
- It is suitable for investors who want a flavor of both asset classes with relatively lower risk
- Targets regular income through debt portion.

Investment approach

- **Debt Approach** – The fund is actively managed and has a diversified portfolio. It aims to capture opportunities in the yield curve spreads in the short duration segment. It aims to have a target portfolio duration of 1-7 years.
- **Equity Approach** – The fund follows a bottom up stock picking approach with a bias towards large cap stocks. The emphasis is on quality stocks with sustainable growth potential.

Fund Manger Views

- Over the past 15 years, Indian equities have navigated multiple geopolitical events—regional conflicts, border tensions and global wars—with only brief and shallow drawdowns. In almost every instance, markets stabilised once it became clear that economic growth, earnings and policy frameworks remained intact. Long-term returns have ultimately been driven by domestic demand, investment cycles and corporate profitability, not by geopolitics. For investors, the enduring lesson remains unchanged: periods of uncertainty are best met with discipline, diversification and patience. Staying invested through volatility has consistently proven more rewarding than reacting to fear, as fundamentals tend to reassert themselves over time.
- Going forward, markets are likely to continue rewarding companies with high earnings visibility, sustained profitability and strong structural growth drivers, available at reasonable valuations. Stock selection will remain critical, with a preference for domestic-oriented sectors over export-heavy plays.
- On the Debt side, Since February 2025, we have been steadily reducing portfolio duration, shifting away from long-duration strategies toward accrual-focused approaches. This year, we see accrual and selective tactical duration as the dominant themes, particularly in long bonds and state development loans (SDLs).
- Our preferred positioning includes 2-year AA-rated corporate bonds for steady accrual and long-tenor government securities for duration plays, offering a combination of consistent accrual and potential upside.

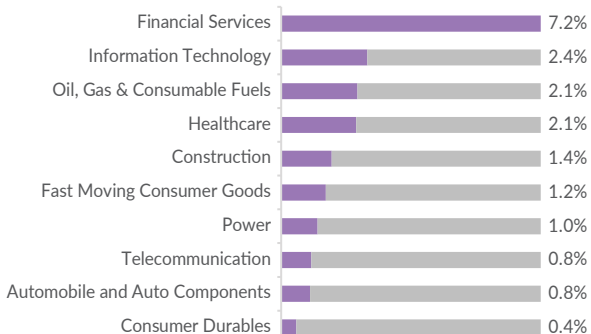

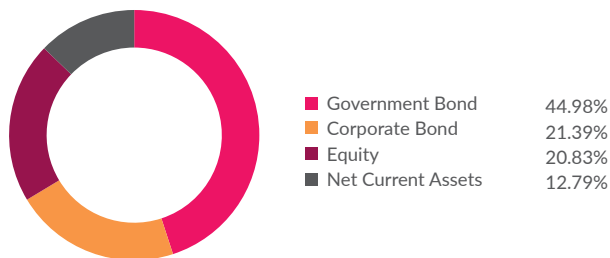

Asset Allocation



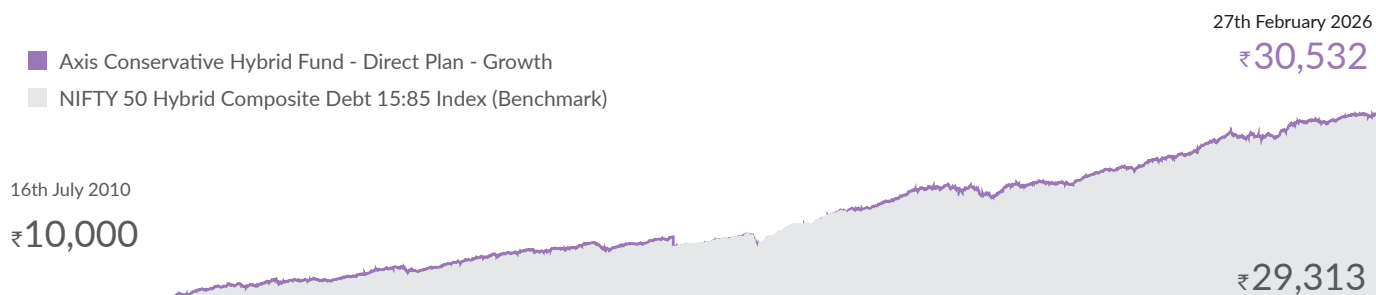

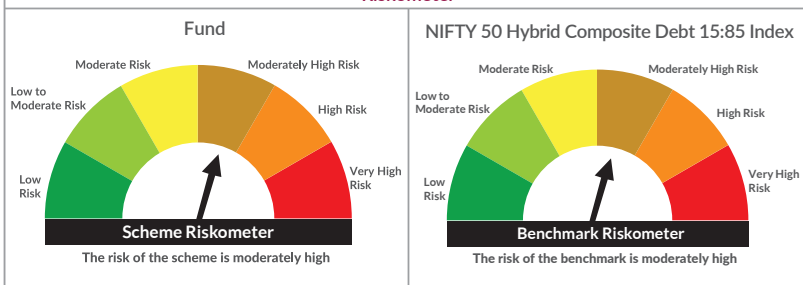
