About the Fund

A strategy focusing on companies with Strong E-S-G (Environment, Social and Governance) attributes offering long term sustainable growth prospects (with up to 30% allocation to global stocks)



Aim for long term capital appreciation by investing in quality companies with sustainable growth prospects



It is well positioned to incorporate ESG while investing basis our core focus towards quality and sustainable growth



International Equity exposure up to 30% to capture ESG opportunities across the global landscape

Why Axis ESG Integration Strategy Fund?

- **Stringent screening process:** At Axis, we follow a process designed based on inputs by Schroders. The process includes a detailed ESG assessment on stock inclusion from the universe. This is followed by annual stock-level screening and reviews based on any specific ESG issues faced by the companies.
- **Sustainable companies:** We look for truly sustainable companies with strong fundamentals. The companies should not only be able to offer a rich source of alpha but also have a positive social impact. Minimum 80% of the portfolio will be in stocks that rate highly on an internal ESG Review.

Annual stock-level ESG review to capture changes to operating environment



Review of specific ESG issue faced by any company in the universe



Active engagement with management – improved disclosures, proxy voting

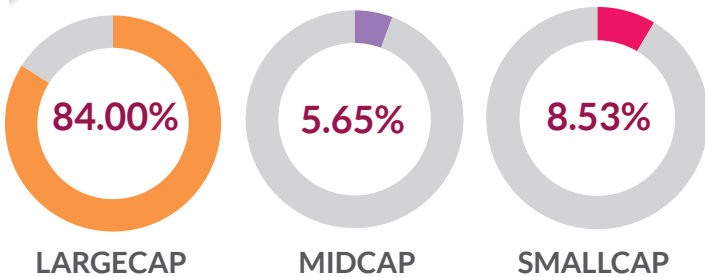

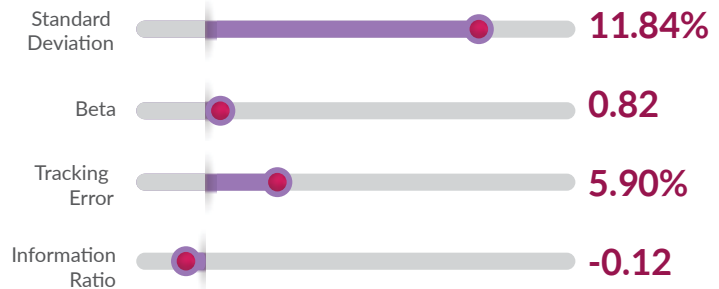

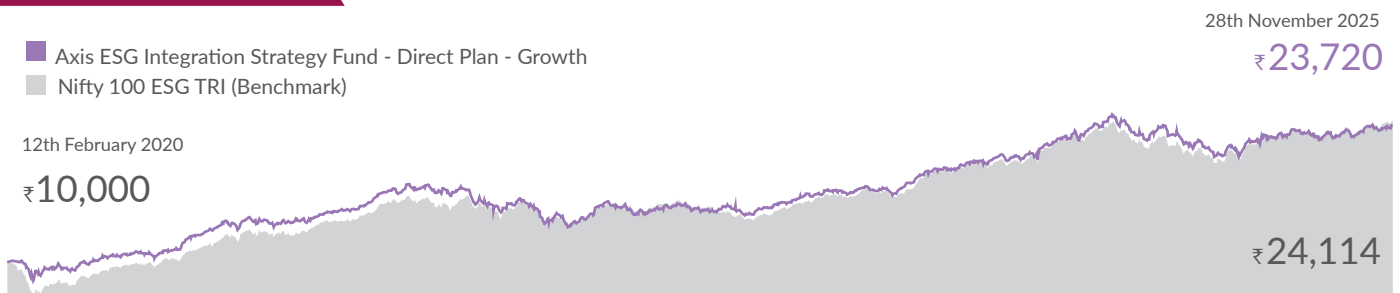
