## Why Axis ESG Integration Strategy Fund?

- **Stringent screening process:** At Axis, we follow a process designed based on inputs by Schroders. The process includes a detailed ESG assessment on stock inclusion from the universe. This is followed by annual stock-level screening and reviews based on any specific ESG issues faced by the companies.
- **Sustainable companies:** We look for truly sustainable companies with strong fundamentals. The companies should not only be able to offer a rich source of alpha but also have a positive social impact. Minimum 80% of the portfolio will be in stocks that rate highly on an internal ESG Review.

Review of specific ESG issue faced by any company in the universe





## Top 10 Sectors






