This is followed by annual stock-level screening and reviews based on any specific ESG issues faced by the companies.
- Sustainable companies: We look for truly sustainable companies
 with strong fundamentals. The companies should not only be able
 to offer a rich source of alpha but also have a positive social
 impact. Minimum 80% of the portfolio will be in stocks that rate
 highly on an internal ESG Review.






