Why a Innovation Fund?

- Financial markets are slow in recognizing these opportunities and a innovation fund may be able to see an unanticipated change which may be overlooked otherwise.

Fund Manager Views

- With global rate cycle changed to easing, interest in high growth disruptive stocks has increased in line with global indices viz. Nasdaq100. There is keen focus on competitive positioning and stability of business model in terms of profitability as well as cash flow generation.
- Fund follows a Multicap approach, with focus on capturing growth from innovation across market cap, sectors and geographies
- Currently, the fund is positioned more than 50% in Platform and AI ecosystem.
- The fund endeavours to target Innovative growth opportunities across the entire value chain both in India & abroad. The focus is on innovative themes like platform businesses, Hi-tech manufacturing, AI ecosystem, financial digitalization, Tech innovation etc. The endeavour is to invest from a long-term perspective, as some companies may not be profitable but hold significant potential in the long run.




