*The above framework is broadly indicative and the fund manager may change the framework depending on the market conditions

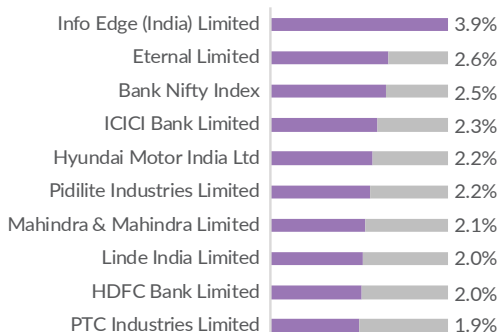
Why a Innovation Fund?

- Financial markets are slow in recognizing these opportunities and a innovation fund may be able to see an unanticipated change which may be overlooked otherwise.

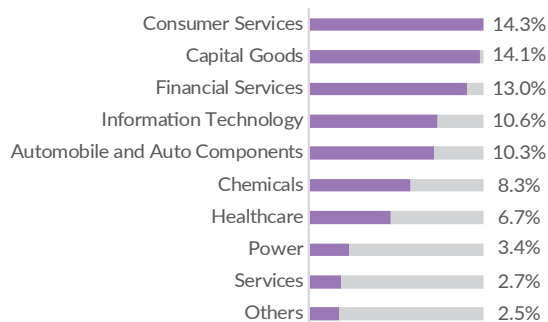
Fund Manager Views

- With global rate cycle changed to easing, interest in high growth disruptive stocks has increased in line with global indices viz. Nasdaq100. Valuations across PE funded as well as potential IPO companies which had come off, are gradually recovering on a selective basis taking into consideration relative growth and earnings delivery of these companies, post listing in the markets. Also, there is keen focus on competitive positioning and stability of business model in terms of profitability as well as cash flow generation.
- Fund follows a Multicap approach, predominantly large cap with active allocation calls on mid and small cap. The global portion is in large caps. Overall retaining our quality bias and investment philosophy.
- The fund endeavours to target Innovative growth opportunities across the entire value chain both in India & abroad. Through a multi cap approach the fund will focus on identifying current innovative themes (not just in India but globally too), then narrow it down to specific sectors. The endeavour is to invest from a long-term perspective, as some companies may not be profitable but hold significant potential in the long run.
- Currently, the fund is focusing on Industrial product, technology (hardware, software, semiconductors, EMS), Healthcare, Auto (EV), Renewables and other such innovative themes.

Current Portfolio Allocation is based on the prevailing market conditions and is subject to changes depending on the fund manager's view of the equity markets.

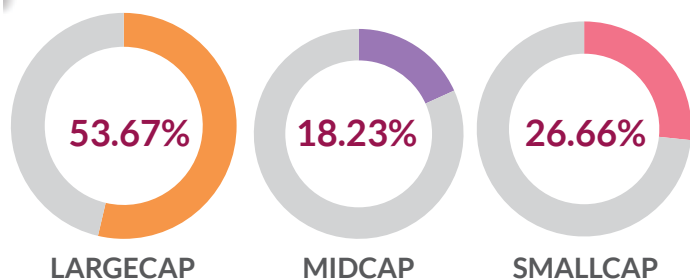

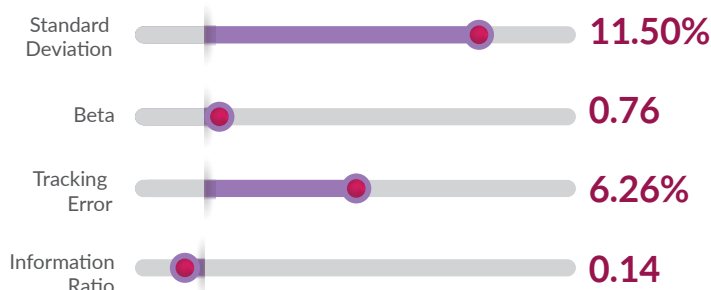

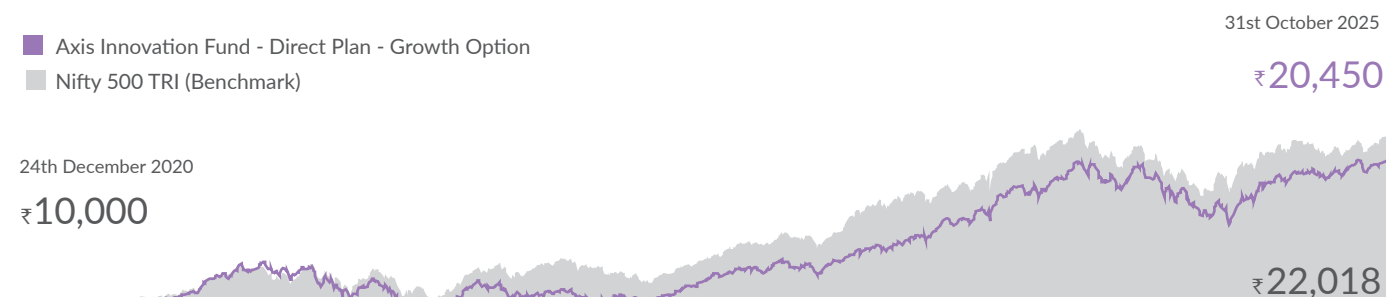
