About the Fund

Large and midcap strategy with sectoral diversification.

The fund aims to capture the global opportunities that are not available for domestic investors and will comprise primarily of global large caps. Key markets currently include America, Europe, ex- UK middle east, emerging markets & Japan.



Domestic large caps* - Typically 30-35%



Foreign stocks around 15-25% (predominantly large caps).



Domestic midcaps* - Typically 35-40%

*The above framework is broadly indicative and the fund manager may change the framework depending on the market conditions

Why look at global allocation?

- Global portfolio provides access to themes and companies that are not available in India
- Opportunities to invest in sunrise sectors unavailable in India
- Global allocations help better withstand event shocks

Investment Strategy

Domestic stocks are selected in the portfolio based on:

- Innovative & entrepreneurial companies with experienced management
- Market leaders in emerging industries or higher growth companies in established businesses

The Overseas allocation is based on advice from Schroders Investment Management and follows a high conviction alpha strategy.

Stock ideas are based on:

- Stocks where the current price doesn't reflect future prospects
- Companies expect to deliver future earnings growth above consensus over 3-5-year horizon
- Material environmental, social and governance (ESG) factors

Fund Manager Views

- The global economy focus remains on evolving geopolitical tensions, the impact of policy changes and tariff implementation. We believe at this juncture; impact of the global events is highly unpredictable. Portfolio tilt is towards companies with higher dependence on domestic markets/consumers and expanding addressable market opportunities, could emerge as potential winners in the near future.
- Coordinated policy measures from the RBI and the Government such as rate cuts, CRR reduction, liquidity infusion, accelerated capex and nearly Rs1.5 trn in GST reductions aimed at boosting mass consumption.
- The fund has a large cap bias, given the relative safety amidst the current market environment. The midcap allocation Favors companies with market leadership attributes and largely consumer facing business models. Given the elevated valuations, we have rotated positions across segments, currently we are OW on banks, capital goods, Healthcare and Pharma. We will remain in consolidation mode, based on earning growth profile.
- Given the concerns on geopolitical issues such as tariff and Geo-political concerns, and pace of Global growth, we remain at low exposure to global stocks. However, we maintain we balanced exposure of traditional and new age companies name.




