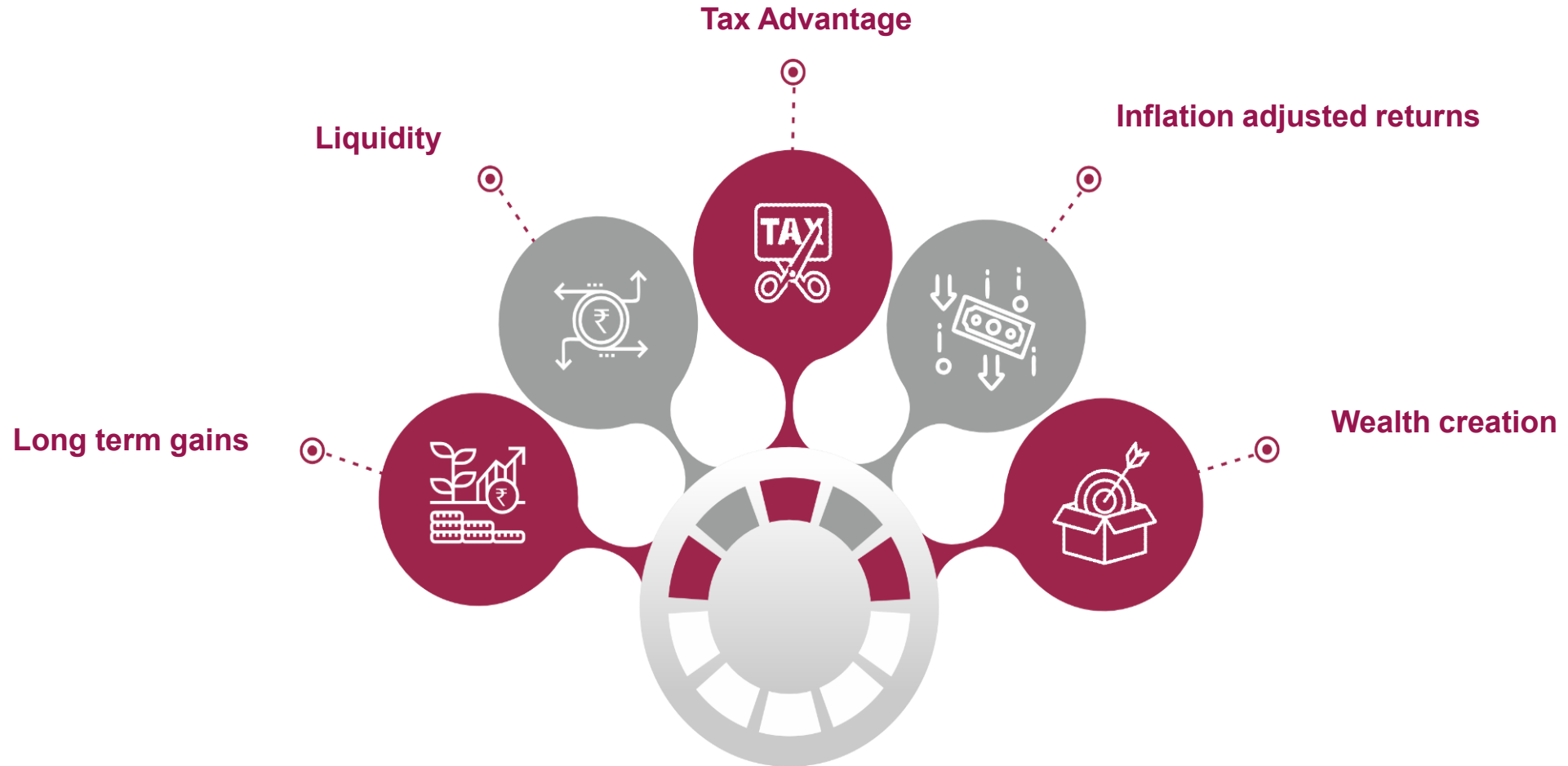

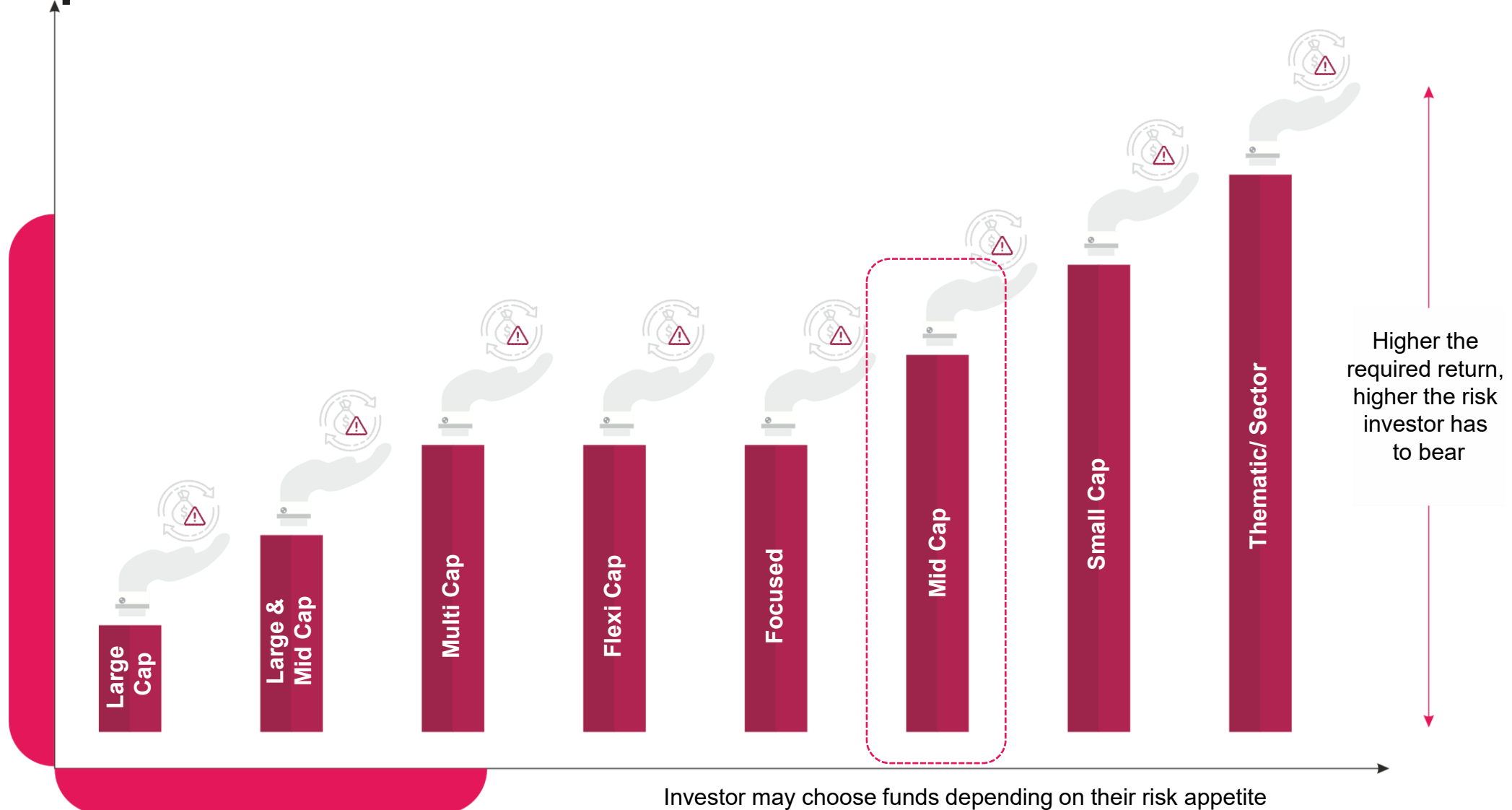

Illustration: Active Equity Funds Risk Return Spectrum

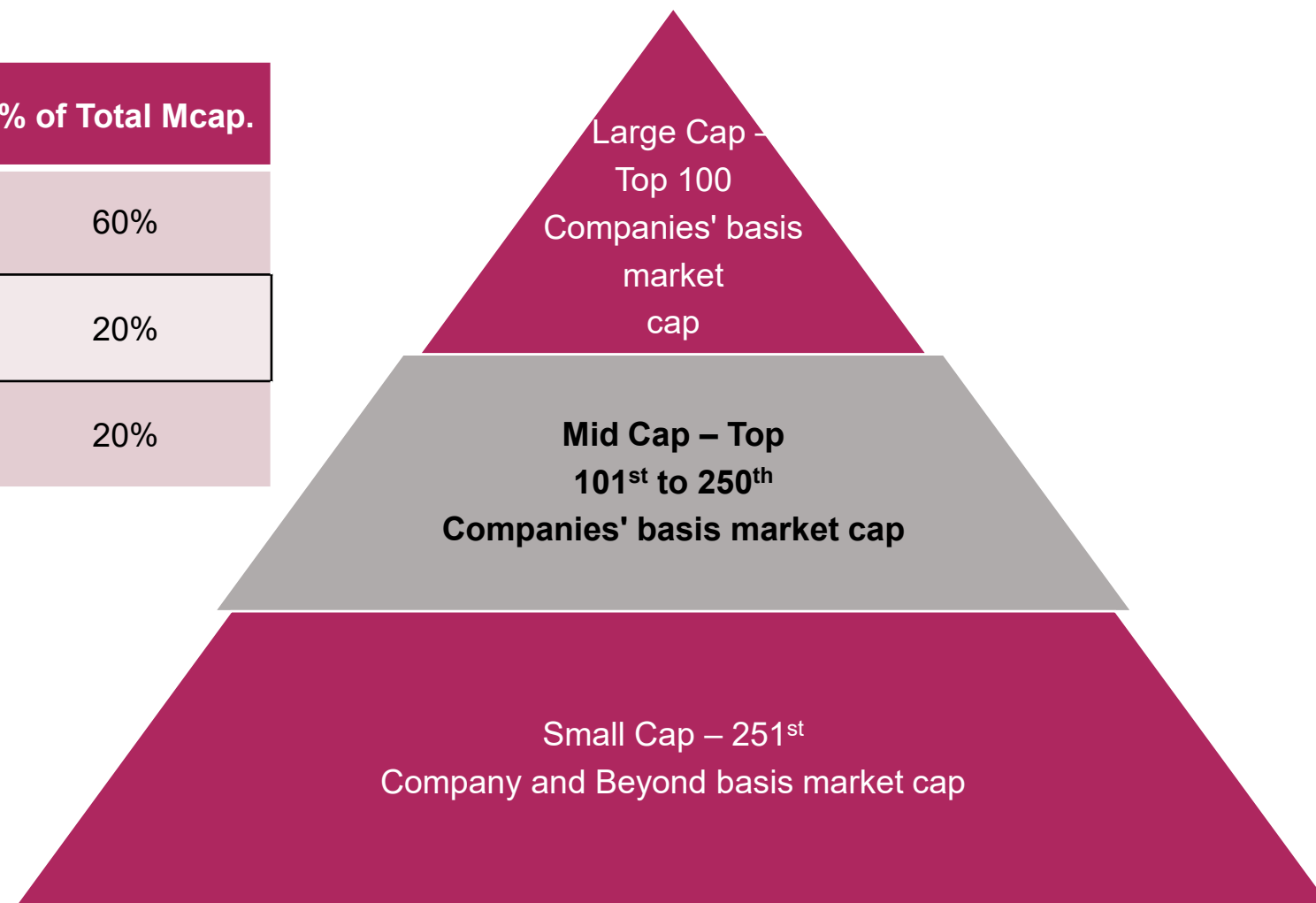

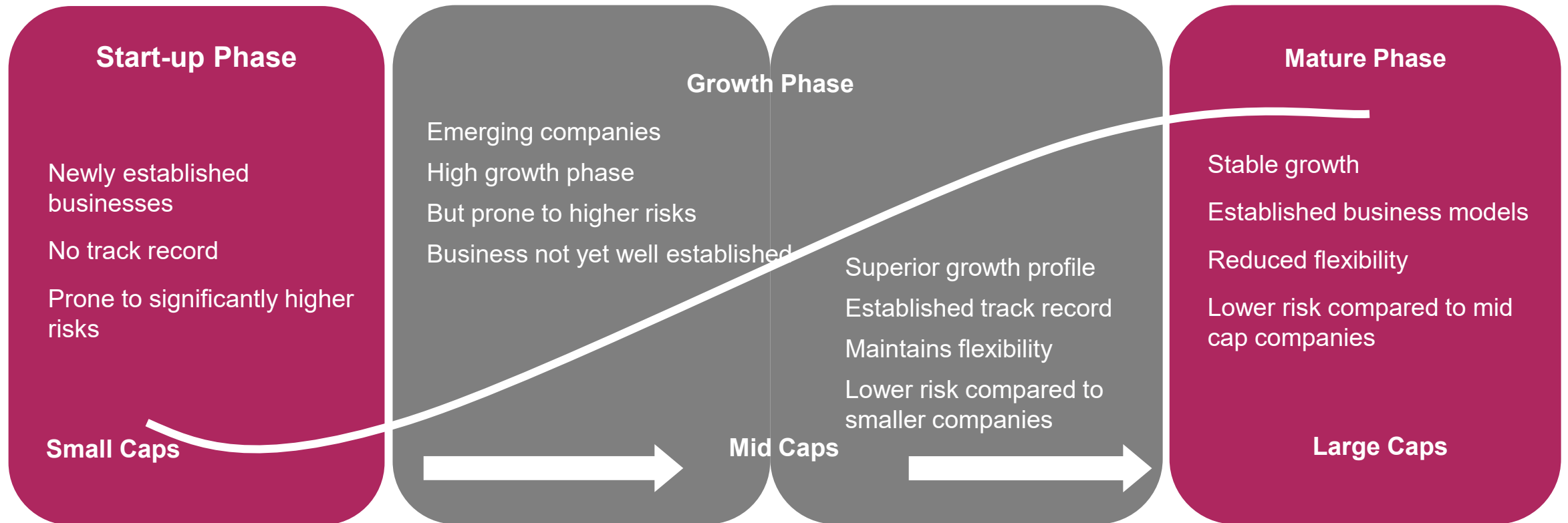

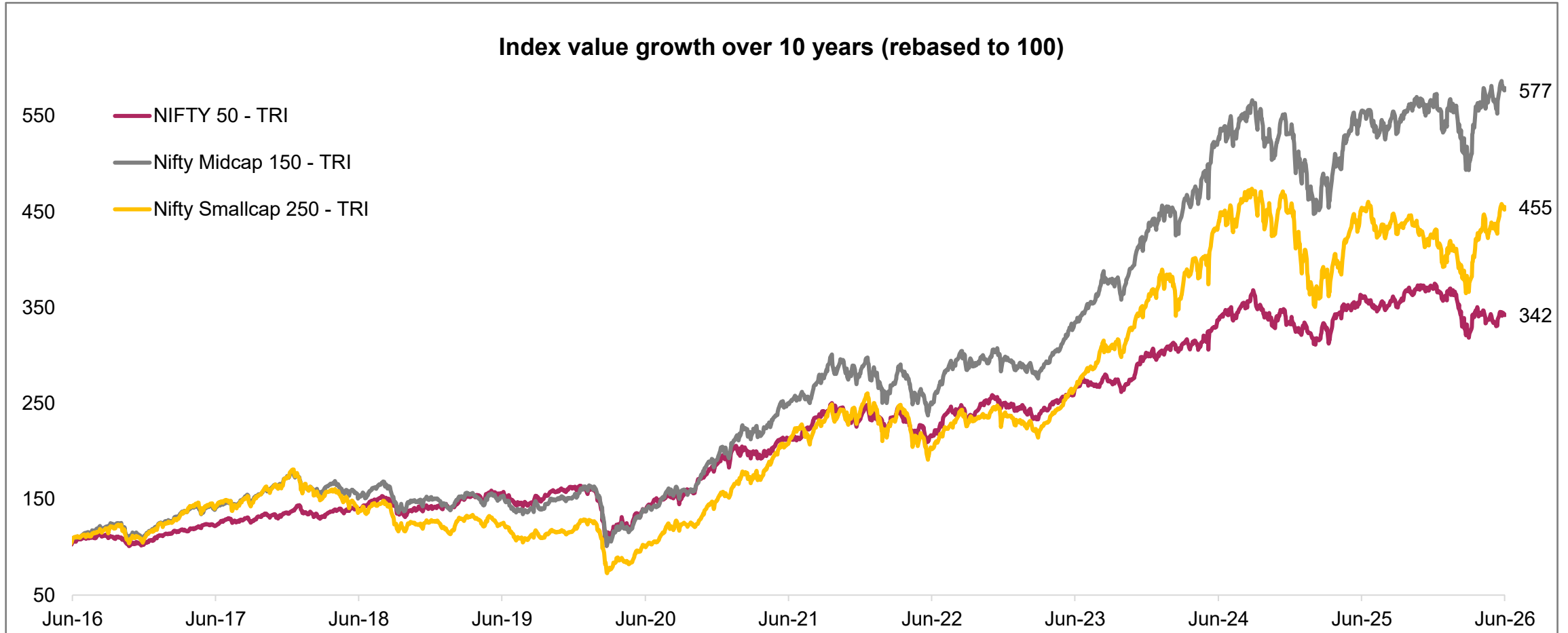

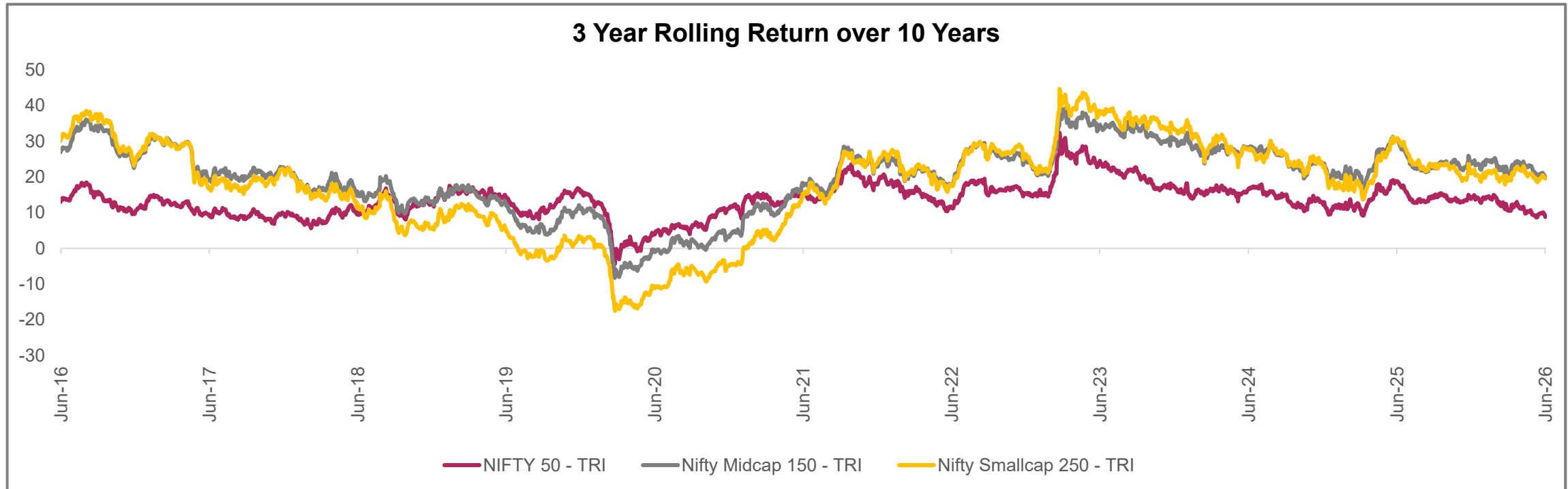


Long term growth potential for Midcaps

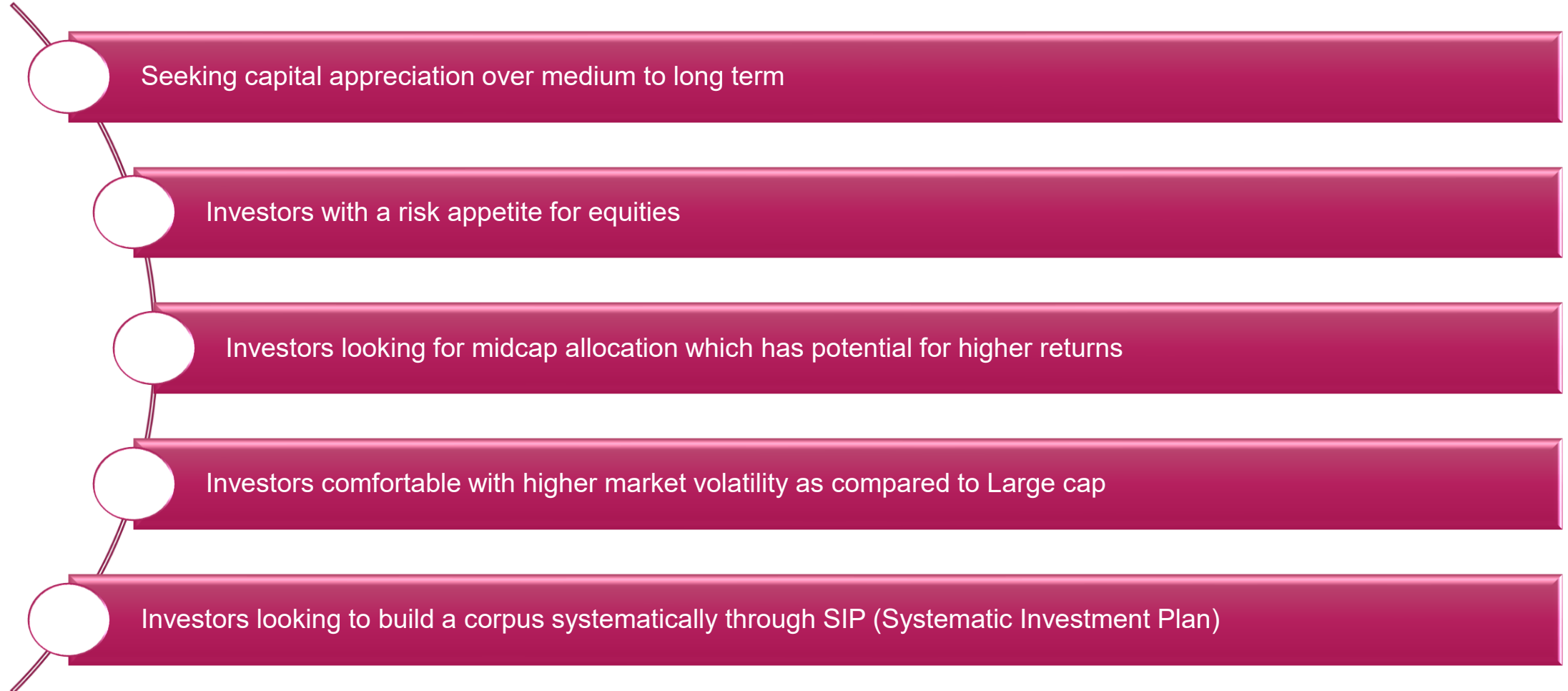
