The framework filters securities by considering data availability and liquidity, and then evaluates them based on price momentum trends.

Momentum as a strategy is a dynamic signal, and the active management of the momentum strategy in the Axis Momentum Fund allows it to capture opportunities as market dynamics evolve. This makes it a flexible and responsive investment option.

Momentum investing can be a powerful tool when combined with a diversified asset allocation strategy. By incorporating momentum funds alongside broad-based index funds, investors can benefit from high-performing stocks while managing overall portfolio risk.

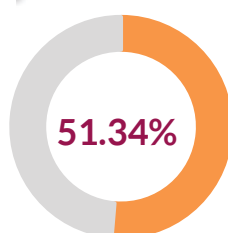
Fund Manager Views

- The fund follows a momentum-based strategy that seeks to identify and invest in stocks exhibiting strong price strength and trend persistence across market capitalizations.
- The portfolio combines quantitative stock selection with active portfolio management, ensuring that emerging momentum opportunities are identified and incorporated through regular monitoring and rebalancing. This allows the fund to remain aligned with evolving market trends while maintaining a diversified portfolio.
- Current portfolio positioning reflects a diversified momentum opportunity set across market capitalizations, with 51% in large caps, 28% in mid-caps and 21% in small caps. Sector exposures are led by Banks, Industrial Products, Pharmaceuticals & Biotechnology, highlighting the model's focus on areas exhibiting strong momentum and earnings traction.

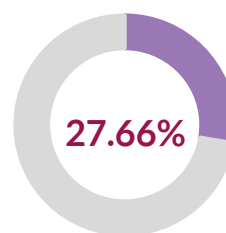

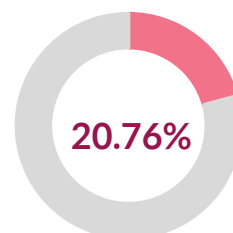
Current market cap split (% NAV)

SMALLCAP

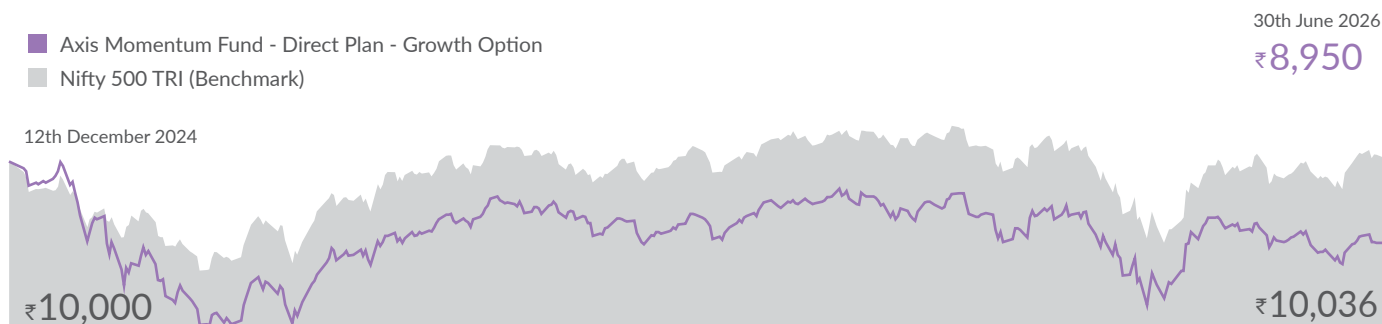

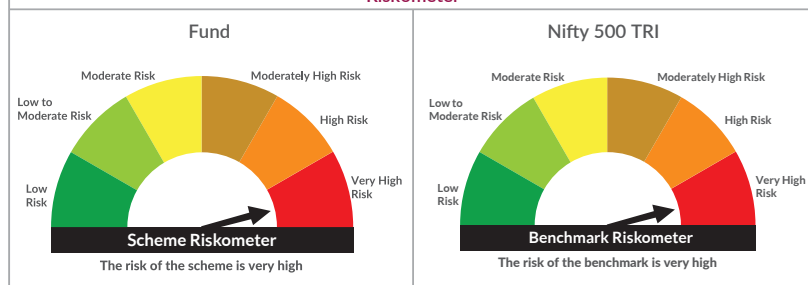
