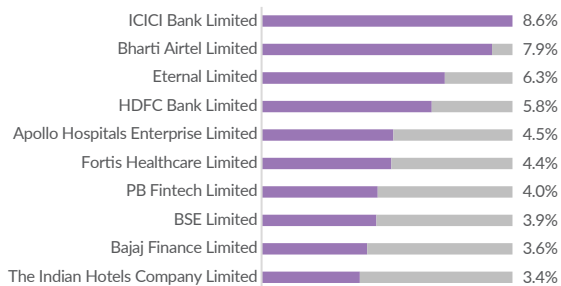

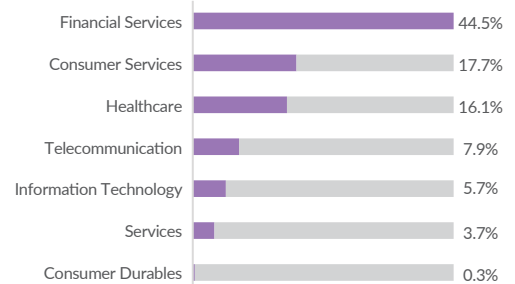
Why Axis Services opportunities Fund?

Top 10 Sectors

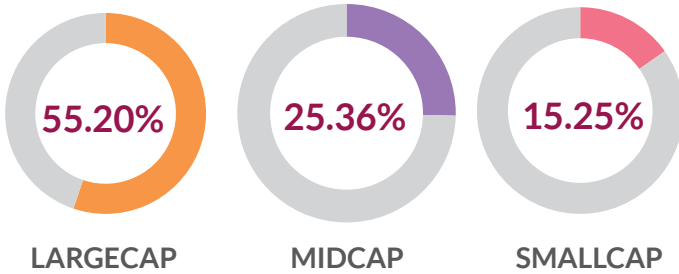



