About the Fund

Systematically invest in units of Axis Silver Fund of Fund, a Fund-of-Fund investing in units of Axis Silver ETF, an exchange traded fund with physical silver as an underlying asset. One can invest in a disciplined manner with amounts as small as ₹ 1000 per month through Systematic Investment Plan (SIP) mode. Or if you so desire you can invest one time lump sum amounts starting from ₹ 1000.

Fund Manager Views

- ▶ Silver peaked above USD 115/oz earlier in 2026 and has since corrected, with prices consolidating in the USD 65–80/oz range in April 2026
- ▶ Silver's unique positioning as both a precious and industrial metal gives it a dual demand profile. It benefits from safe haven flows during uncertain times, while also riding on structural industrial trends such as electrification, solar energy, and electronics manufacturing
- ▶ Industrial demand forms the backbone of silver consumption, with applications expanding across green technologies and semiconductors. Investment flows into silver-backed instruments tend to be more volatile but often mirror broader sentiment around inflation and currency stability.
- ▶ Silver supply remains constrained due to its nature as a by-product of other mining activities. This structural limitation, coupled with rising industrial demand, has led to recurring supply deficits in recent years.
- ▶ Silver is likely to remain a high-beta play within the precious metals space, which is reflective in near term prices. Its performance will be influenced by macroeconomic shifts, industrial momentum, and investor appetite for alternative assets.

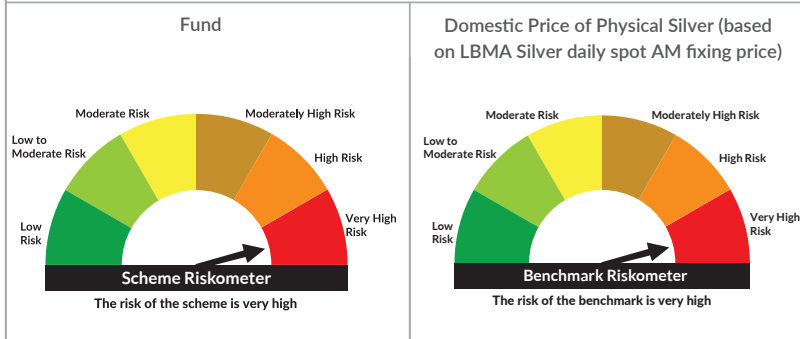
