

## NOTICE

The time of receipt of transaction requests on AMC server (irrespective of time of sending of email by investor) will be considered as time of receipt of such application by AMC for determining applicability of NAV. In all such cases redemption payment will be made only to the unitholders registered bank account.

All AMF investors and distributors are requested to bear with the mutual fund and to use the digital / electronic modes for their mutual fund transactions.

Please avoid travelling except for medical reasons or emergencies till the situation becomes normal and stay healthy.
